



## In Your Home PET CARE

### SERVICE CONTRACT

#### PET CARE

1. I (CLIENT) authorize IYHPC to perform pet care services as outlined on the "House and Pet Information Sheet" which shall become part of this contract.
2. If the pet(s) become ill while under the care of IYHPC, I authorize the sitter designated by IYHPC to care for my pet(s), to transport my pet(s) to my veterinarian (or one who is available) if this is needed, in his/her best judgment. I authorize IYHPC to approve any emergency treatment recommended by the Veterinarian and I agree to pay promptly for charges incurred. I release IYHPC from all liabilities related to transportation, treatment, and expense.
3. In the event of severe weather I authorize the sitter assigned by IYHPC to use his/her best judgment in caring for my pet(s) and home.

#### PAYMENT

1. Pet care services will be provided at the starting rate of \$\_\_\_\_\_ per day/visit. Rates for subsequent services are subject to change.
2. If CLIENT returns before scheduled visits are complete, or for any reason no longer requires the Services of IYHPC, and fails to adequately notify IYHPC of such, any visit or trip resulting from such failure to notify shall be compensated at the above rate. PET SITTING CANNOT BE GUARANTEED if client notifies IYHPC that additional visits to pet(s) are needed after scheduling has been agreed upon. If CLIENT fails to notify IYHPC of additional visits and PET SITTER continues visits after the originally agreed upon date and time, compensation will be **twice the amount indicated above.**

3. I agree to reimburse IYHPC for any additional fees for tending to emergency or veterinary care as well as expenses incurred for any other unexpected home, food, or other special needs.
4. I agree to pay in full on the day the services are rendered.

### **LIABILITY**

1. Customer expressly waives and relinquishes any and all claims against IYHPC, its employees and Associates, except those arising from negligence on the part of IYHPC.
2. It is expressly understood and agreed that IYHPC shall not be held responsible for any damage to CLIENT'S property, or that of others, caused by CLIENT'S pet(s) during the period in which they are in its care. I have advised IYHPC of other situations that will relieve it of liability for damage.
3. If a dog has a history of biting, IYHPC reserves the right to refuse service. Bites must be reported to the local authorities as provided by law. The owner will be liable for the sitter's medical care, expenses and damages that result from an animal bite.

### **FURTHER SERVICES**

I authorize this contract to be valid approval for future services so as to permit IYHPC to accept my telephone reservations and enter my premises without additional signed contracts or written authorizations.

### **Outdoor Cats**

In Your Home Pet Care expressly waives and relinquishes any and all claims against IYHPC and its employees in the case of accidental injuries while the cat is outdoors as per owner's request.

### **Dogs/cats Without ID tags**

In Your Home Pet Care expressly waives and relinquishes any and all claims against IYHPC and its employees in the case of accidental injuries or loss of pet in an emergency/natural disaster while in our care without ID tags on the pet by owner's choice.
